Therefore, LuxFLAG handles your personal data with care and ensures that your personal data is processed in accordance with the EU General Data Protection Regulation. We will not send any personal data to third parties, except if required to do so by law, a government body or a private party in connection with a lawsuit, court decision, investigation or similar proceedings.

# What personal data does LuxFLAG process?

If you are not a client, LuxFLAG is processing your personal data based on legitimate interest. LuxFLAG will process your personal data for the sole purpose of sending you information and/or invitations related to sustainable finance matters and the association's activities.

If you are subscribing to our newsletter using a webform you submit your personal details. In that case, LuxFLAG will process the following personal information: your name, gender, email address and organization. Your preferences with regard to what type of documents you wish to receive, and invitations may be changed at any time. You can unsubscribe at any time via the Unsubscribe link at the bottom of the emails you receive or by writing to us.

Please kindly note that some of the databases or systems used by LuxFLAG for mailing services and storage systems may be hosted and/ or maintained by third party service providers located inside or outside of the European Union. To send out our mailings, we currently use a mailing program called MailChimp which processes your name, title, email address and organization. MailChimp participates in and has certified its compliance with the EU-U.S. Privacy Shield Framework and the Swiss-U.S Privacy Shield Framework. They are committed to subjecting all Personal Information received from European Union (EU) member countries and Switzerland, respectively, in reliance on each Privacy Shield Framework, to the Framework's applicable Principles.

If you are a client, we process your data on the basis of the agreement we have with you and also, to comply with our legal obligations, including the obligation to identify our relations and those under tax law. The personal data we will process includes your name, title, position, postal address, email address and phone number in order to get in touch with you.
